4. Quotation exceeding the Approved Budget for the Contract shall be rejected.
5. Award of Contract shall be made to the Lowest Quotation which complies with the minimum technical specification and other terms and conditions stated therein.
6. Any interlineations, erasure or overwriting shall be valid only if they are signed or initialed by you or your authorized representative/s.
7. The item/s shall be delivered according to requirement specified in the Technical Specifications.

9. All items must be delivered in clean, food-grade containers and transport vehicles. Advanced delivery without valid and justifiable reasons, prior approval and coordination for available storage space shall be rejected.
10. The BJMPRO-VIII shall have the right to inspect supplies, warehouses, and delivery packaging to be used to conform to the technical specifications.
11. Liquidated damages equivalent to one tenth of one percent of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The BJMPRO-VIII shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other course of action and remedies open to it.
